

**GARRETT RETIREES ACTION COMMITTEE
REGISTRATION FORM**

The **Garrett Retirees Action Committee** investigated the various aspects that contribute to how our pension benefits were calculated. These concerns addressed the offsets (i.e. Secured Benefits (SBA) and Social Security). We hired an “Actuary” to analyze the formulas associated with our pension calculations. It is the opinion of our attorney and the actuary that the Allied Signal Plans violated the terms of the Plans and ERISA with respect to amendments and merger of Plans and in the calculation of our retirement benefits. With this in mind, we filed a Claim Letter with Honeywell on July 26, 2002. Honeywell denied our claim and after various legal communications it was determined that we would file a Class Action lawsuit against Honeywell. The lawsuit was filed on March 1, 2004. **On September 6, 2006 Judge Roslyn Silver, United States District Judge, ordered the Certification of the Class Action. It could involve 12,800 former Garrett employees that meet the following requirements: “You worked for one of the Garrett Companies on 12/31/83 and prior, and you retired after 1/2/84”.**

We are asking all eligible retirees to join us in our effort to resolve this issue. **You can join the Garrett Retirees Action Committee Roster by completing our registration form and forwarding to the Committee.**

Over one thousand of your fellow retirees and current employees who worked for one of the Garrett Companies prior to 1/02/84 have financed this legal action up to this point. Because our expenses will continue under the class action, we are now asking each member to bring their contribution amount up to \$400 and new members to contribute \$400 to help defray the expenses associated with “your lawsuit”. All of the funds we collect are applied to the attorney office expenses related to our lawsuit committee expenses, and the actuaries’ expenses. Martin & Bonnett are on a contingency, therefore, we are not responsible for any attorney billed hours.

We need all retirees to contribute to insure that we will be successful in our efforts. We are challenging a large corporation. **Some retirees have developed the philosophy that they will benefit even if they don’t contribute. Nothing could be further from the truth. If we fail to support this financially, no one will benefit. We are in the home stretch.** We will prevail with support of all retirees. Please get the word out to your fellow retirees who meet the requirements. If you are acquainted with fellow retirees who do not have a computer, please inform them with a copy of this page, or give them the phone numbers of the committee, so they may contact us for further information.
